## Tournament Rules

## "5 Person Baker Team Tournament"

1. Teams consist of five bowlers. Each bowler will bowl two frames each game. Player in the first position will bowl frames 1/6. Player in the second position will bowl frames $2 / 7$. Player in the third position will bowl frames $3 / 8$. Player in the fourth position will bowl frames 4/9. Player in the fifth position will bowl frames 5/10.
2. This tournament is not USBC sanctioned.
3. Each game will be bowled on a single lane. A total of 15 games will be bowled for the qualifying round. If you start on an odd lane, you will move one lane to the right each game. If you start on an even lane, you will move one lane to the left each game.
4. All bowlers will use their highest 2022-2023 USBC league average, unless their current USBC average of 21 games or more is 10 pins or more higher than their 2022-2023 average. If a bowler has no average, then must use an average of 220. All averages will be verified before the conclusion of the tournament. A team can be disqualified if they report an incorrect average.
5. Team handicap is determined by $90 \%$ of the difference of the team average minus 1200 divided by 5 .
6. Entry Fee is 150 per team and must be paid before practice begins. All pre-registered entries must be paid online at www.colonyparklanesnorth.com. Side pots will be available at the tournament director's discretion.
7. Format is 15 baker style games in the qualifying round. After qualifying the top three teams will move to a stepladder final. The first match will be third seed vs second seed and the second match will be the winner of the first match vs first seed. Qualifying standings will be determined by the highest 15 games total score plus handicap. Finals will be determined by the first team to win two games head to head. If a team that makes the finals does not show up to bowl by the time the match is ready to begin, they forfeit the match and receive the money for the lower place.
8. Payout ratio will be 1:5. Estimated prize list based on 20 teams is as follows: First place is 1,000 . Second place is 600 .Third place is 350 .Fourth place is 250 .

## "King Of The Hill Tournament"

1. This tournament is scratch singles tournament. Each round is a head to head format one game higher score wins. If you lose two matches you are eliminated from the tournament. Once you lose one match you move to the consolation bracket.
2. This tournament is not USBC sanctioned.
3. Entry fee is 41 dollars if paid online before November $20^{\text {th }}$. Starting November $20^{\text {th }}$ entry fee is 46 dollars. Only paid spots will be reserved. Maximum entries allowed is 96 . Walk ins will be accepted until 96 entries are reached. Side pots are available. High game pots are only for the first two games. Winner take all side pot will be awarded to the bowler who enters that finishes the highest in the main bracket. Consolation side pot will be awarded to the bowler who enters that finishes the highest in the consolation bracket.
4. Consolation will pay 3 winners with the top payout being $\$ 150$ based on 96 entries.
5. Main bracket will pay based on 96 entries as follows: $1^{\text {st }} \$ 500,2^{\text {nd }} \$ 250,3^{\text {rd }}-4^{\text {th }} \$ 150,5^{\text {th }}$ $8^{\text {th }} \$ 100,9-12 \$ 50$.
6. Score sheets must be filled out completely and given to the tournament director after each round. The tournament director will announce when lane assignments can be drawn for each round.
7. Youth may bowl in this event with a signed Youth Eligibility form, with all winnings in the form of scholarship going to their SMART account.
